**ELIGIBILITY CRITERIA IS AS FOLLOWS:**

1. A LEARNER MUST BE ENROLLED AT A PARTICULAR PUBLIC BOARDING SCHOOL.
2. A LEARNER MUST HAVE QUALIFIED TO GRADE EIGHT OR ALREADY ENROLLED IN GRADE 9 TO 12.
3. SCHOOL DROP-OUTS WHO FAILED TO PAY SCHOOL FEES SHALL BE ELIGIBLE FOR A BURSARY.
4. LEARNERS THAT ARE ENROLLED IN THE BOARDING SCHOOLS BUT ARE ACCOMMODATED IN THE NEARBY VILLAGES DUE TO FAILURE TO PAY BOARDING FEES.
5. DOUBLE ORPHANED WHERE THE GUARDIAN HAS NO RELIABLE SOURCE OF INCOME.
6. SINGLE ORPHAN WHERE THE SURVIVING PARENT HAS NO RELIABLE SOURCE OF INCOME.
7. A LEARNER WITH DISABILITY.
8. LEARNERS WHOSE PARENTS ARE DISABLED AND HAVE NO RELIABLE SOURCE OF INCOME.
9. LEARNERS WHOSE PARENTS OR GUARDIANS HAVE NO RELIABLE SOURCE OF INCOME.
10. LEARNERS ON THE SCHOOL RE-ENTRY PROJECT WITHOUT FAMILY SUPPORT
11. A LEARNER FROM A POOR, VULNERABLE AND INCAPACITATED HOUSEHOLD WHERE A VULNERABLE HOUSEHOLD HAS THE FOLLOWING CHARACTERISTICS;
12. PRESENCE OF STUNTED OR UNDERWEIGHT CHILDREN.
13. CHILDREN OUT OF SCHOOL
14. FEMALE HEADED HOUSEHOLD.
15. HOUSEHOLDS HEADED BY CHRONICALLY ILL AND ON PALLIATIVE CARE.
